

Improved IEP Quality and Special Education Teacher Satisfaction in Massillon City Schools



Massillon City Schools are in northeast Ohio, approximately 50 miles south of Cleveland in Stark County. Around 4,000 students are enrolled. The district is home to eight schools: three elementary schools and a preschool, intermediate school, junior high school, high school, and career tech center. Special services in Massillon City Schools believes that:

- All students can grow
- Collaboration among parents and educators is essential to student success
- When high expectations are set, students will meet them
- Students with disabilities will be educated in their least restrictive environment along a continuum of services
- Students with disabilities require intervention, specially designed instruction, and core
 content instruction in order to demonstrate growth and close the achievement gap

The Story of Massillon City Schools

Massillon City Schools district believes in educating all students, including those with disabilities, in the least restrictive environment. To do this, Massillon leadership allocates IDEA-B and ARP IDEA-B funds to maintain and/or increase related services and support personnel, purchase appropriate instructional supplies and materials, and provide family and community engagement activities. These resources ensure that unique learners receive the Free and Appropriate Public Education (FAPE) detailed in their IEP.

At the district level, [Rebecca Moore, District Student Service Support Specialist,] felt that goal writing had "become very repetitive."

The Challenge

Rebecca Moore, District Student Service Support
Specialist, stated that her district "constantly seemed
to struggle with new goal" writing or writing meaningful
goals for students' IEPs. At the district level, she felt
that goal writing had "become very repetitive."
To combat this and ensure that IEPs were impactful
to each unique learner, Rebecca provided professional
development to teachers twice a year as well as weekly
updates. Even with training, IEP writing is stressful and
time-consuming for educators, taking away valuable
time that can be spent teaching students. Massillon
City Schools sought a solution that would support
IEP writing, incorporate student data, and save

With embedded IEP writing guidance, teachers would have the support they need to write accurate and compliant present levels statements and high-impact, high-quality IEPs. These types of IEPs must include individualized SMART goals and have present levels statements that teachers create based on student data.




The Results
