Background

Davidson County Schools are in the Piedmont area of North Carolina near Winston-Salem. Stoner-Thomas School, one of 36 schools in Davidson County, specifically serves students with special needs. Currently, it has 96 students, ages 5 through 22. Stoner-Thomas School was approved by the state of North Carolina to participate in the North Carolina Alternative Schools' Accountability Model (ASAM), meaning additional accountability information is reported to the state as required by the Every Student Succeeds Act (ESSA).

The Story of Stoner-Thomas School

Serving unique learners comes with its own distinct challenges, and Stoner-Thomas School works hard to ensure they meet the needs of each student as well as their teachers. As a school that serves only students with special needs, IEPs are the center of their collaborative culture and process.

The Challenge

Planning, writing, executing, and monitoring progress on IEPs was laborious and time-consuming at Stoner-Thomas School. Teachers needed a tool that would support them in writing IEPs that contained consistent, measurable goals based on student data and state learning standards. Stoner-Thomas needed a comprehensive IEP solution to 1) maintain and achieve compliance, and 2) improve teacher satisfaction.

MAINTAIN AND ACHIEVE COMPLIANCE

For Rachael Cusick, Compliance Case Manager at Stoner-Thomas, it was a requirement that an IEP solution ensures IEP goals are based on student performance data. In addition, it was essential that those goals be SMART to ensure data could be easily collected. The goals also needed to be based on observable, measurable criteria. “The biggest obstacle and risk to compliance were inconsistencies with goal writing,” said Rachael. Collaboration prior to the IEP meeting—which included all members of the IEP team, especially families—was crucial as well.

IMPROVE TEACHER SATISFACTION

“Special education teachers are busy and consistently receiving increased roles and responsibilities in our school,” acknowledged Rachael. Retaining teachers starts with supporting them and ensuring their satisfaction in the classroom by guaranteeing they have the time to teach rather than focusing on the abundant paperwork.

Stoner-Thomas was already using other n2y solutions in their classrooms. 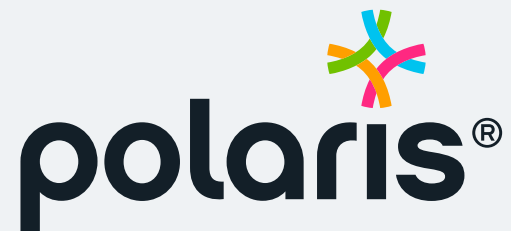
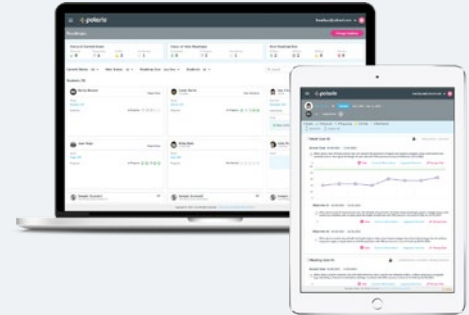
The Results
